# JAMAICA CIVIL AVIATION AUTHORITY STATISTICAL REPORT – JANAUARY TO JUNE 2020



#### Aircraft Movement - NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) in June 2020 were **1365**, a decrease of **76%** when compared to the **5,703** aircraft movement recorded in June 2019.

Year to date, January to June 2020, aircraft movements at both international airports decreased by **44%**, with **20,458** aircraft movements compared to **36,803** in 2019.


## Norman Manley International Airport (NMIA)


Aircraft movements at NMIA in June 2020 totaled **974**, a decrease of **58%** when compared to same period in 2019 where movements were **2,342**. Of the **974** aircraft, **301** were international scheduled aircraft, **528** military aircraft and **145** private aircraft. For the 2019 period of the **2,342** aircraft, **1,456** were international scheduled aircraft, **8** domestic aircraft, **652** military aircraft and **226** private aircraft.


## Sangster's International Airport (SIA)

At the SIA total aircraft movements in June 2020 were **391** compared to **3,361** aircraft a decrease of **88%** for the same period in 2019. Of the **391** aircraft in June 2020 **248** were international non-scheduled, **20** military aircraft and **123** private aircraft. For the 2019 period of the **3,361** aircraft **2,286** were international scheduled aircraft, **367** international non-scheduled, **262** domestic aircraft, **21** military aircraft and **425** private aircraft.

#### AIRCRAFT MOVEMENT – KTP, NEG, IFIA, POT

Overall aircraft movements for the period April to June 2020 at the domestic aerodromes were **399** a decrease of **83%** from the **2,283** aircrafts recorded for the same period in 2019.

#### **TINSON PEN (KTP)**

For the period April to June 2020 aircraft movement at Tinson Pen decreased by approximately **56%** to **331** aircraft; **163** arrivals and **168** departures, conversely for same period in 2019, **754** aircraft were recorded; **370** arrivals and **384** departures.

#### **NEGRIL (NEG)**

In the period April to June 2020, aircraft movements fell by **98%** to **22** aircraft from **1,182** aircraft reported for the 2019 period. Arrivals for the 2020 period were **11** and departures **11**. Conversely the 2019 period recorded **592** arrivals and **590** departures.

#### IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

decreased by **84%** to **34** with equal landings and takeoffs. Movements for the 2019 period were **207** aircraft with **103** landings and **104** takeoffs.


## **KEN JONES (POT)**


Ken Jones Aerodrome noted **12** aircraft movement from April to June 2020. This was a **91%** dip from **140** aircraft arrivals and departure for the period in 2019. 2020 recorded equal arrivals and departures. In 2019 there were 74 arrivals and 66 departures.



# **CARGO ACTIVITY AT NMIA & SIA**

Cargo movements at international airports for the month of June 2020 were **1,652 metric tonne (MT)**, which was a **17**% decrease when compared to the same period in 2019 which saw **1,930MT** of freight. Freight movement at NMIA June 2020 was **1,411MT**, **444MT** loaded freight and **967MT** unloaded freight. On the other hand, SIA contributed **241MT** of freight, **203MT** loaded and **38MT** of unloaded freight.



Freight Movement at NMIA & SIA 2020 vs 2019



# **Overflight Aircraft Movements**

The month of June 2020 reported a record low overflight aircraft movement of **2,560**, this represents an extreme decrease of **74**% from the **9,784** overflight aircraft movements in June 2019. The average number of daily overflights for the months of June 2019 and 2020 were **326** and **85** respectively.

Year to date, January to June 2020, arrivals decreased by **43%** with **35,458** overflight movements compared to **62,441** arrivals.

## Passenger Movements at NMIA & SIA

Total passenger (includes international and domestic passengers) movements at NMIA and SIA in the month June 2020 were a record low of **29,947**, a drastic decline of **95%** form the figure reported in June 2019, which was **553,320** departures, arrivals and transit passengers.

For the second quarter of 2020, April to June, passenger movements were down **98%**, with **38,871** passengers compared to **1,652,673** in 2019.

Year to date, January to June 2020, passenger movements decreased by **54%**, with **1,542,036** passenger arrivals and departures compared to **3,408,737** in 2019.

## **Passenger Arrival by Region**


June 2020 recorded low passenger arrivals of **14,875** passengers, this was a huge dip of **95%** in comparison to **274,263** passenger arrivals in 2019.

For the second quarter of 2020, April to June, passenger arrivals were down **98%**, with **15,581** passengers compared to **794,190** in 2019.

Year to date, January to June 2020, passenger arrivals decreased by **57%**, with **710,310** passenger arrivals compared to **1,639,926** in 2019.

For the January to June period 2020, arrivals from the United States market accounted for **67% (475,283)** of total arrivals, this was followed by the Canadian market which contributed **17% (119,458)**, United Kingdom arrivals was **6% (44,350)**, European arrivals amounted to **4% (24,841)** and Latin America and the Caribbean contributed **2% (12,851)** and **5% (33,511)** respectively.

The market share for the corresponding period in 2019 was approximately the same with American market arrivals 69%, Canadian 15%, United Kingdom 7%, Europe 4%, Caribbean 4% and Lantin America 1%.



# Passenger Arrival by Operating Airline & Load Factor

The figure below depicts the distribution of passenger arrivals by airline carriers for the period January to June 2020 and 2019 period. Topping the list for the 2020 period, we find American Airlines with **145,000** passengers, followed by Delta Airlines with **96,000** passengers, thirdly we have JetBlue Airways with **85,000** passengers.

Load Factor is calculated by dividing the total number of passengers carried by an aircraft by the total number of seats available on that aircraft, **expressed as a percentage**. For the June 2020 period load factor was approximately 58%. Year to date 2020, we saw where approximately **68%** of all international flights were occupied.
