

Aircraft Movement - NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period July to September 2020 were **8,520**, a decrease of **52**% when compared to the **17,868** aircraft movement recorded in the same quarter in 2019.

Year to date, January to September 2020, aircraft movements at SIA & NMIA decreased by **47%**, with **28,878** aircraft movements compared to **54,671** in 2019.


Norman Manley International Airport (NMIA)

Aircraft movements at NMIA for the third quarter 2020 totaled 5,235, a decrease of 37% when compared to same period in 2019 where movements were 8,271. Of the 5,235 aircraft, 2,107 were international scheduled aircraft, 20 International non-scheduled aircraft, 21 domestic aircraft, 2,327 military aircraft and 760 private aircraft. For the 2019 period of the 8,271 aircraft, 4,959 were international scheduled aircraft, 8 domestic aircraft, 2,443 military aircraft and 861 private aircraft.

Sangster's International Airport (SIA)

At the SIA total aircraft movements in the third quarter of 2020 were **3,285** compared to **9,597** aircraft in the same period in 2019, a decrease of **66%**. Of the aircraft for the 2020 period **2,359** were international scheduled, **173** international non-scheduled, **199** domestic aircraft, **29** military aircraft and **525** private aircraft. For the 2019 period of the aircraft **6,257** were international scheduled aircraft, **1070** international non-scheduled, **650** domestic aircraft, **100** military aircraft and **1,520** private aircraft.

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period July to September 2020 at the domestic aerodromes and IFIA were **995** a decrease of **56%** from the **2,266** aircraft recorded for the same period in 2019.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period decreased by **48%** to **527** aircraft; **263** arrivals and **264** departures, conversely for same period in 2019, **1,009** aircraft were recorded; **495** arrivals and **514** departures.

NEGRIL (NEG)

Negril Aerodrome also reported a decrease in aircraft movement for the July to September 2020 period. Movements fell by **63**% to **356** aircraft from **956** aircraft reported for the 2019 period. Arrivals for the 2020 period were **180** and departures **176**. Conversely the 2019 period recorded **479** arrivals and **477** departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)


In the third quarter 2020, IFIA aircraft movement decreased by **76%** to **54** with equal landings and takeoffs. Movements for the 2019 period were **227** aircraft with **113** landings and **114** takeoffs.


KEN JONES (POT)

Ken Jones Aerodrome noted **58** aircraft movement from July to September 2020. This was a **22**% dip from **74** aircraft arrivals and departure for the period in 2019. 2020 recorded **29** arrivals and **25** departures. In 2019 there were **37** arrivals and **37** departures.

Aircraft Movement at Domestic Aerodromes Jan-Sep 2019 & 2020



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period July to September 2020 were **5,183 metric tonne (MT)**, which represents a **15**% decrease from freight movement of **6,096MT** in the same period of 2019. Freight movement for the reporting period at NMIA was **4,400MT**; **1839MT** loaded freight and **2,561** unloaded freight. On the other hand, SIA contributed **783MT** of freight, **669MT** loaded and **114MT** of unloaded freight.



Freight Movement at NMIA & SIA Jan-Sep 2020 vs 2019



Overflight Aircraft Movements

In the third quarter of 2020, July to September, Jamaica FIR recorded a total overflight aircraft movement of **9,522**, this represents a decrease of **68%** from the **30,215** overflight aircraft movements in June 2019. The average number of daily overflights for the period July to September 2019 and 2020 were **328** and **104** respectively.

Year to date, January to September 2020, arrivals decreased by **51**% with **44,980** overflight movements compared to **92,656** arrivals.







Passenger Movements at NMIA & SIA


Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the third quarter 2020 was **294,107** a decline of **82%** from the figure reported for the same period in 2019, which was **1,668,744** departures, arrivals and transit passengers.

Year to date, January to September 2020, passenger movements decreased by **64%**, with **1,836,143** passenger arrivals and departures compared to **5,077,481** in 2019.


Passenger Arrival by Region

Total passenger arrivals for the reporting period is **144,802**. This is a significant decrease of **82%** from the figure of **808,785** arrivals reported for the same period in 2019. Year to date, passenger arrivals are down **65%**, that is **855,112** arrivals from January – September 2020 versus **2,448,711** arrivals for same period in 2019.

Passenger Arrival by Airlines and Load Factor

The table below depicts the distribution of passenger arrivals by airline carriers for the period January to September 2020 period. Topping the list with the most passenger arrivals by carrier for the 2020 period January to September we find American Airlines with approximately **183,000** passengers, followed by JetBlue Airlines with approximately **123,000** passengers, thirdly we have Delta Airline with approximately **109,000** passengers.

Load Factor is calculated by dividing the total number of passengers carried by an aircraft by the total number of seats available on that aircraft, **expressed as a percentage**. Year to date 2020, we saw where approximately **62**% of all international flights were occupied.
