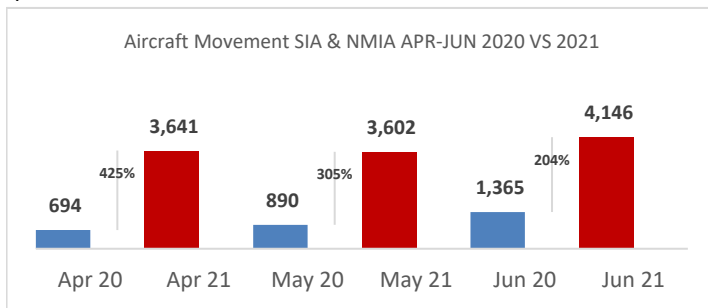

Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period April to June 2021 were **11,389**, an increase of **286%** when compared to the **2,949** aircraft movement recorded in the same quarter in 2020.



Year to date, January to June 2021, aircraft movements at SIA & NMIA increased by **4%**, with **21,244** aircraft movements compared to **20,458** in 2020.

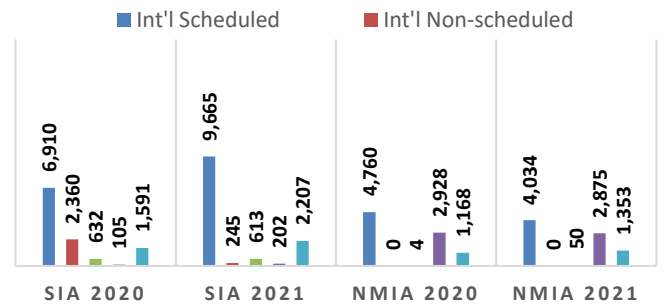
Norman Manley International Airport (NMIA)

Aircraft movements at NMIA for the second quarter 2021 totaled **4,360**, an increase of **85%** when compared to same period in 2020 where movements were **2,352**. Of the total aircraft for the 2021 period, **2,125** were international scheduled aircraft, **23** domestic aircraft, **1,552** military aircraft and **660** private aircraft. For the 2020 period of the **2,352** aircraft, **646** were international scheduled aircraft, **1,371** military aircraft and **335** private aircraft.

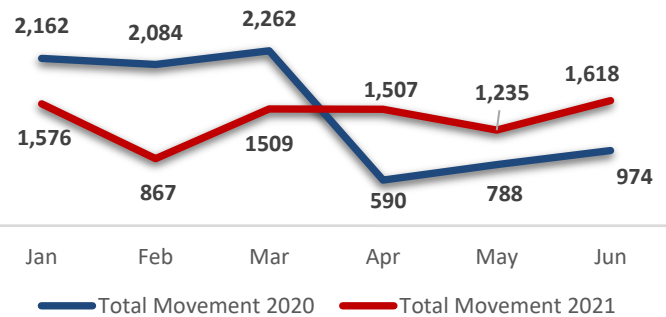
Sangster's International Airport (SIA)

At the SIA, total aircraft movements in the second quarter of 2021 were **7,029** compared to **597** aircraft in the same period in 2020, an increase of **1,077%**. Of the aircraft for the 2021 reporting period **5,239** were international scheduled, **145** international non-scheduled, **318** domestic aircraft, **124** military aircraft and **1,203** private aircraft. For the 2020 period of the aircraft **22** were international scheduled, **381** international non-scheduled, **17** domestic aircraft, **34** military aircraft and **143** private aircraft.

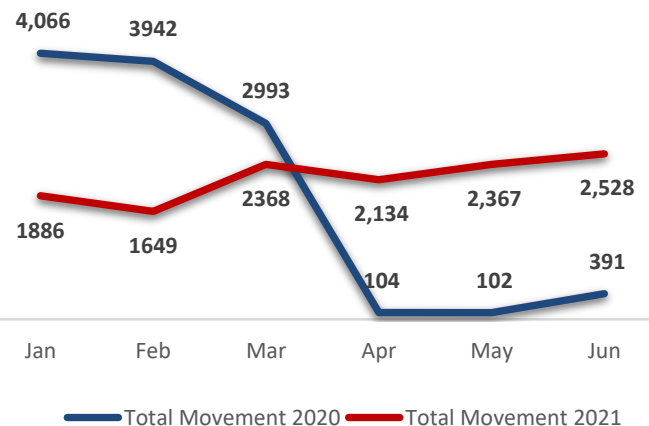
AIRCRAFT MOVEMENT SIA & NMIA JAN - JUN 2020 & 2021

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period April to June 2021 at the domestic aerodromes and IFIA were **2,163** an increase of **429%** from the **409** aircraft recorded for the same period in 2020.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **182%** to **932** aircraft; **472** arrivals and **460** departures, conversely for same period in 2020, **331** aircraft were recorded; **163** arrivals and **168** departures.

NEGRIL (NEG)

Negril Aerodrome also reported an increase in aircraft movement for the April to June 2021 period. Movements increased by **4,405%** to **991** aircraft from **22** aircraft reported for the 2020 period. Arrivals and departure for the 2021 period were **496** and **495** respectively, the 2020 period recorded equal arrivals and departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

Aircraft movement at IFIA increased by **359%** to **156** with equal landings and takeoffs. Movements for the 2020 period were **34** aircraft with **equal** landings and takeoffs.

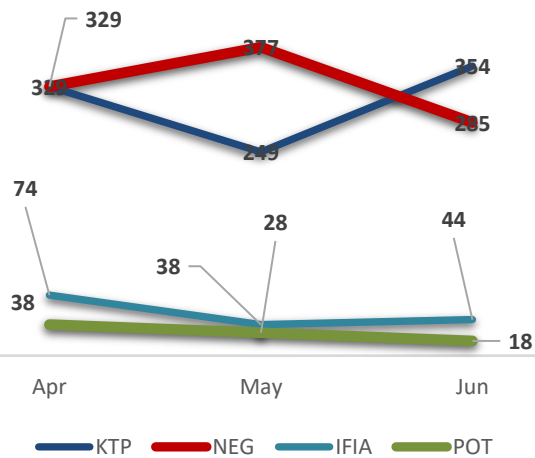
KEN JONES (POT)

Ken Jones Aerodrome noted **84** aircraft movement from April to June 2021. This was a **282%** rise from **22** aircraft arrivals and departure for the period in 2020. There were equal arrivals and **departures**. In 2020 there were equal arrivals and departures also.

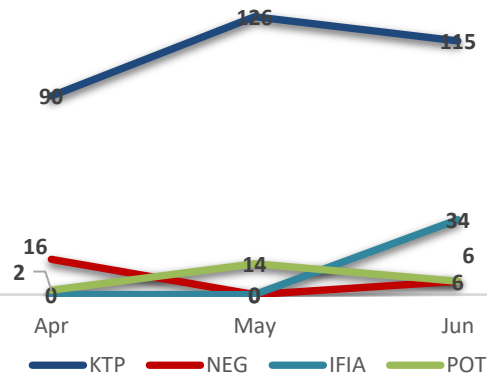

Aircraft Movements at Domestic Aerodromes Apr - Jun 2021



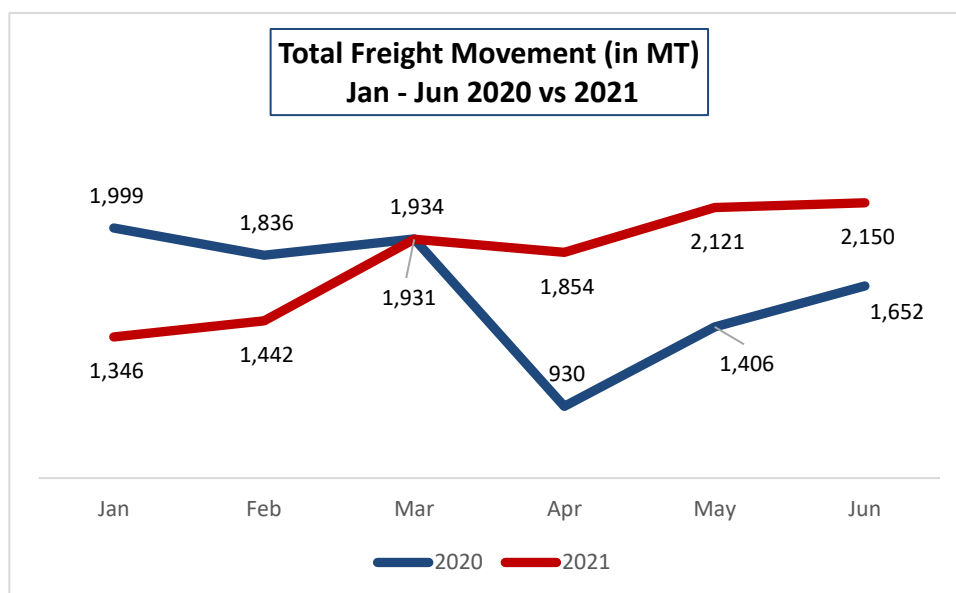
Aircraft Movements at Domestic Aerodromes Apr - Jun 2020



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period April to June 2021 were **6,125 metric tonne (MT)**, which represents a **54%** increase in freight movement from **3,988 MT** in the same period of 2020. Freight movement for the reporting period at NMIA was **4,939MT**; **1,671MT** loaded freight and **3,268** unloaded freights. On the other hand, SIA contributed **1,186MT** of freight, **1,066MT** loaded and **120MT** of unloaded freight.

For the reporting year 2021 freight movement increased by **11%** coming from **9,757MT** in 2020 to **10,844MT** in the year 2021.



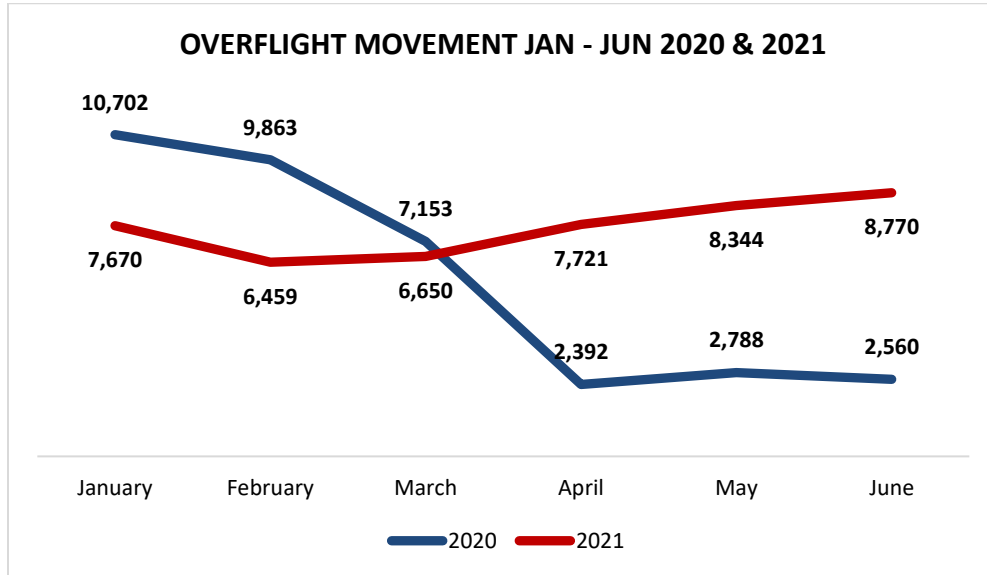

Overflight Aircraft Movements

In the second quarter of 2021, April to June, Jamaica FIR recorded a total overflight aircraft movement of **24,835**, this represents an increase of **221%** from the **7,740** overflight aircraft movements in 2020. The average number of daily overflights for the period April to June 2020 and 2021 were **56** and **272** respectively.

Year to date, January to June 2021, overflight movement increased by **29%** with **45,614** overflight movements compared to **35,458** overflights in 2020.



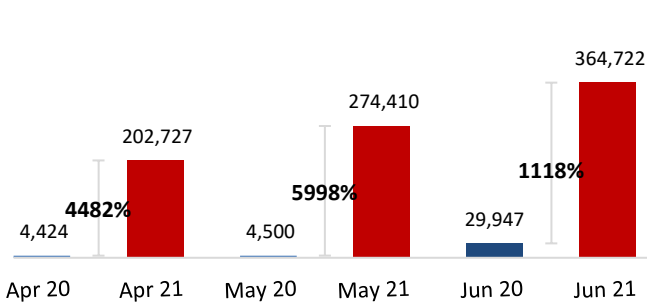

Passenger Movements at NMIA & SIA

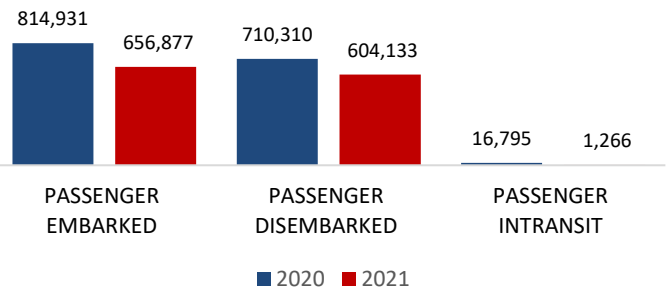
Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the second quarter 2021 was **841,859** an increase of **2066%** from the figure reported for the same period in 2020, which was **38,871** departures, arrivals and transit passengers.

Year to date, January to June 2021, passenger movements decreased by **18%**, with **1,262,276** passenger arrivals and departures compared to **1,542,036** in 2020.

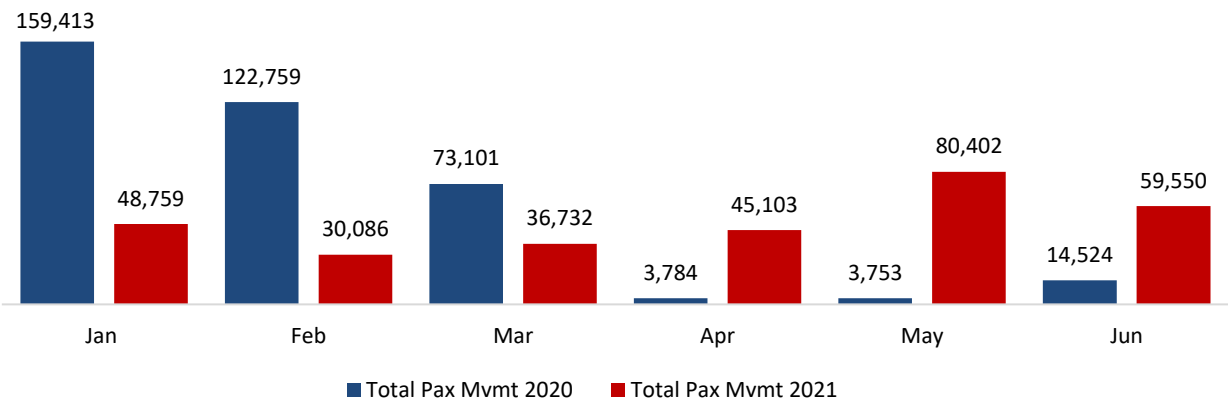
Total Passenger Movement Apr - Jun 2020 vs 2021



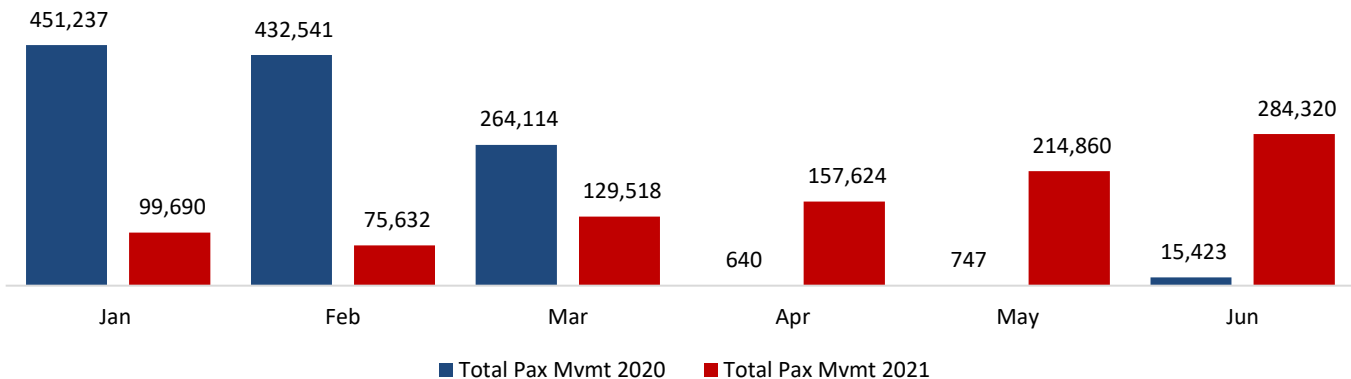
Total Passenger Movement Jan - Jun 2021 vs 2020

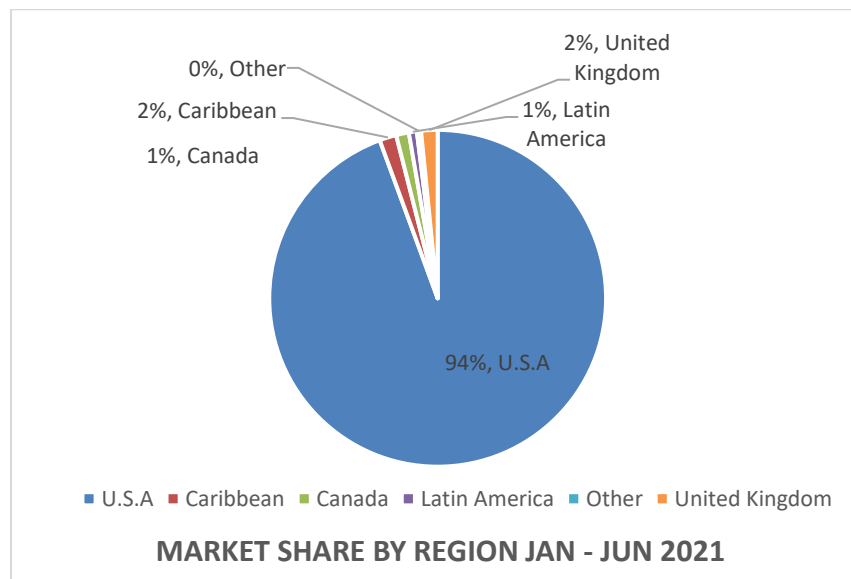

Passenger Arrival by Region

Total passenger arrivals for the reporting period were **410,678**. This is a significant increase of **2486%** from the figure of **15,881** arrivals reported for the same period in 2020. Year to date, passenger arrivals are down **15%**, that is **604,133** arrivals from January – June 2021 versus **710,320** arrivals for same period in 2020.

Passenger Arrival by Airlines and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **78% (470,800)** of total arrivals for the January to June 2021 reporting period. Total arrivals at NMIA for the same period was **133,333** or **22%**.

The load factor for total arrivals for the period January to June 2021 was **58%**. Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **59%** of all international flights were occupied whereas approximately **55%** was occupied at NMIA.

Permits, Flight Authorization and Licenses Issued

For the months of April to June 2021 a total of **88** permits were issued. **83** of these permits were for Single Entity Charter and the remaining **5** were for Cargo Charter. Below is a breakdown of permits issued by region.
