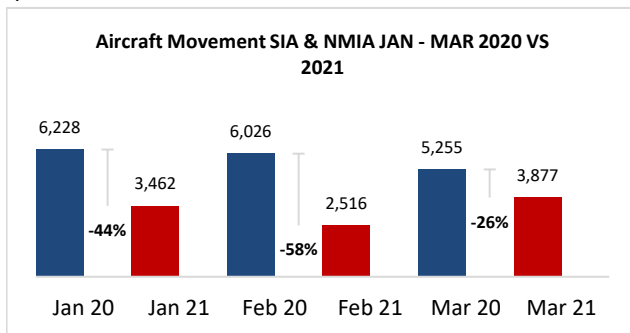

Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period January to March 2021 were **9,855**, a decrease of **44%** when compared to the **17,509** aircraft movement recorded in the same quarter in 2020.



Norman Manley International Airport (NMIA)

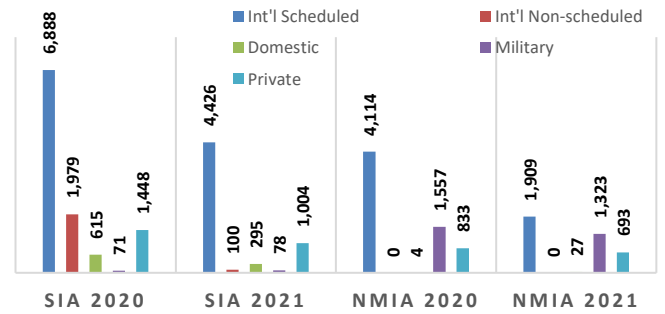
Aircraft movements at NMIA for the first quarter 2021 totaled **3,952**, a decrease of **39%** when compared to same period in 2020 where movements were **6,508**. Of the total aircraft for the 2021 period, **1,909** were international scheduled aircraft, **27** domestic aircraft, **1,323** military aircraft and **693** private aircraft. For the 2020 period of the **6,508** aircraft, **4,114** were international scheduled aircraft, **4** domestic aircraft, **1,557** military aircraft and **833** private aircraft.

Sangster's International Airport (SIA)

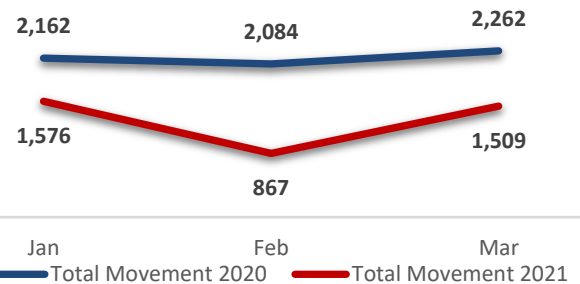
At the SIA, total aircraft movements in the first quarter of 2021 were **5,903** compared to **11,001** aircraft in the same period in 2020, a decrease of **46%**. Of the aircraft for the 2021 reporting period **4,426** were international scheduled, **100** international non-scheduled, **295** domestic aircraft, **78** military aircraft and **1,004** private aircraft. For the 2020 period of the aircraft **6,888** were international scheduled aircraft, **1,979** international non-scheduled, **615** domestic aircraft, **71** military aircraft and **1,448** private aircraft.

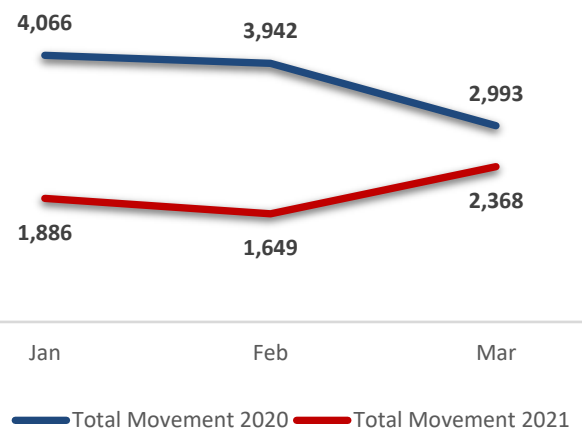
AIRCRAFT MOVEMENT SIA & NMIA JAN - MAR 2020 & 2021

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period January to March 2021 at the domestic aerodromes and IFIA were **1,798** a decrease of **19%** from the **2,220** aircraft recorded for the same period in 2020.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **31%** to **948** aircraft; **469** arrivals and **479** departures, conversely for same period in 2020, **721** aircraft were recorded; **366** arrivals and **355** departures.

NEGRIL (NEG)

Negril Aerodrome also reported a decrease in aircraft movement for the January to March 2021 period. Movements fell by **45%** to **646** aircraft from **1,174** aircraft reported for the 2020 period. Arrivals and departure for the 2021 period was **323** respectively, the 2020 period recorded **590** arrivals and **584** departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

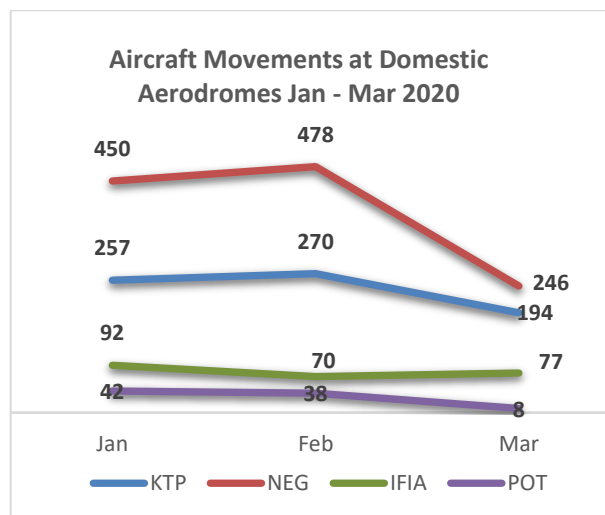
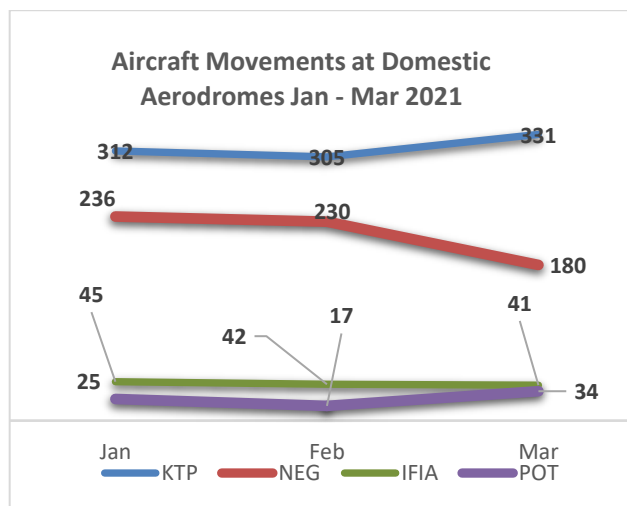
Aircraft movement at IFIA decreased by **46%** to **128** with **65** landings and **63** takeoffs. Movements for the 2020 period were **239** aircraft with **119** landings and **120** takeoffs.

KEN JONES (POT)

Ken Jones Aerodrome noted **76** aircraft movement from January to March 2021. This was a **14%** dip from **88** aircraft arrivals and departure for the period in 2019. 2021 recorded **39** arrivals and **37** departures. In 2020 there were equal arrivals and departures.

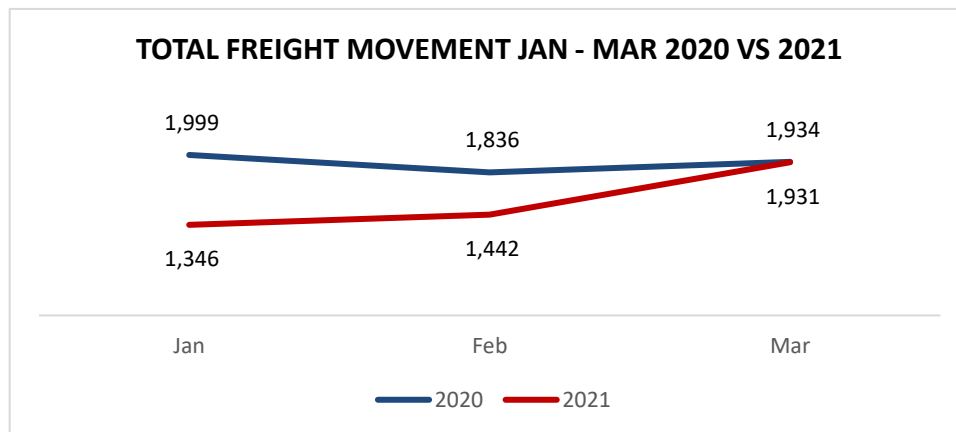

CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period January to March 2021 were **4,719 metric tonne (MT)**, which represents a **18%** decrease from freight movement of **5,769 MT** in the same period of 2020. Freight movement for the reporting period at NMIA was **3,821MT**; **1,229MT** loaded freight and **2,592** unloaded freights. On the other hand, SIA contributed **898MT** of freight, **782MT** loaded and **116MT** of unloaded freight.

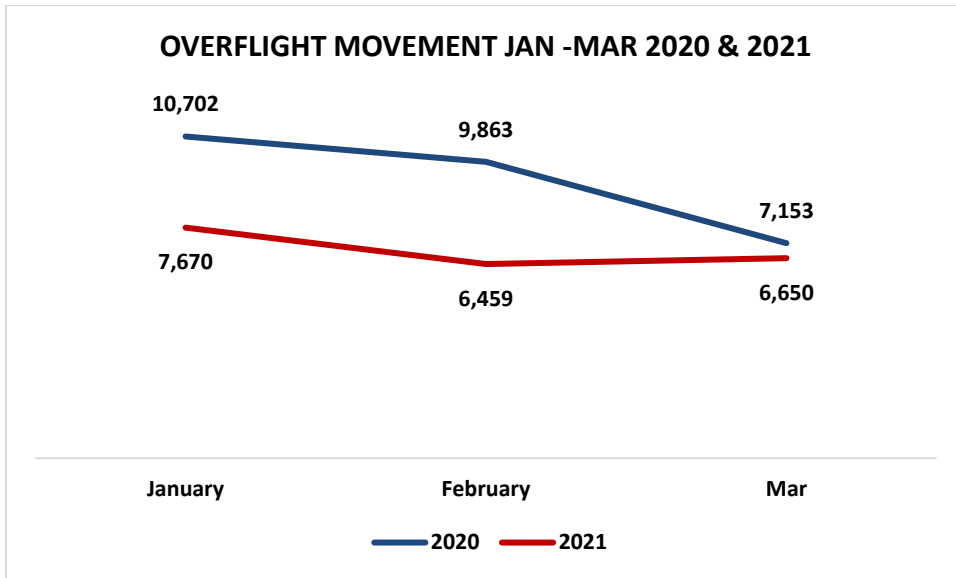

Overflight Aircraft Movements

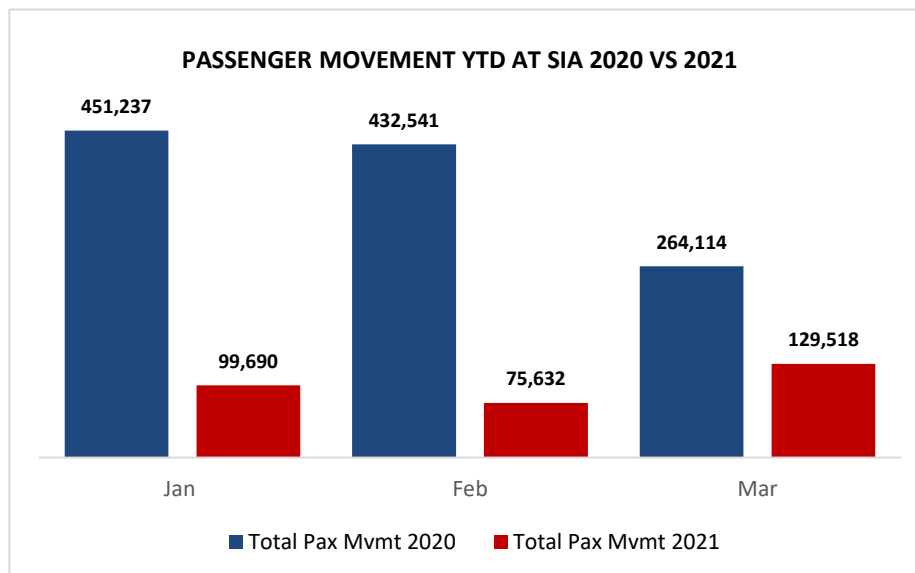
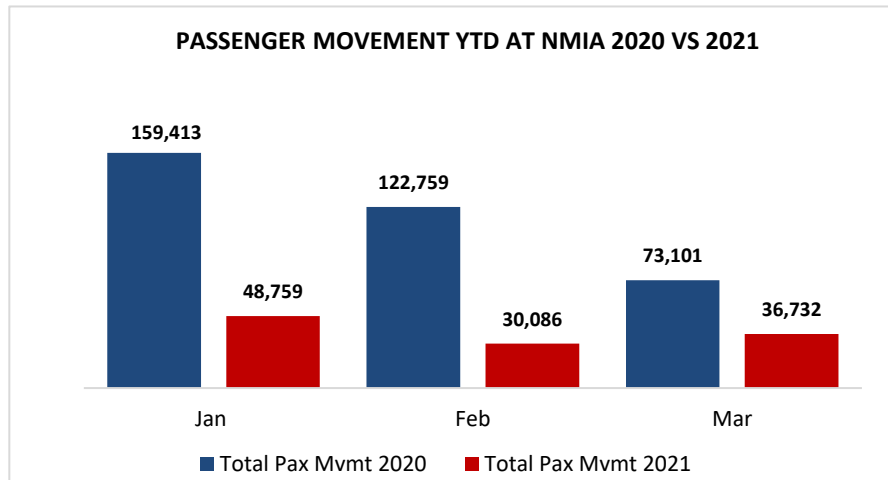
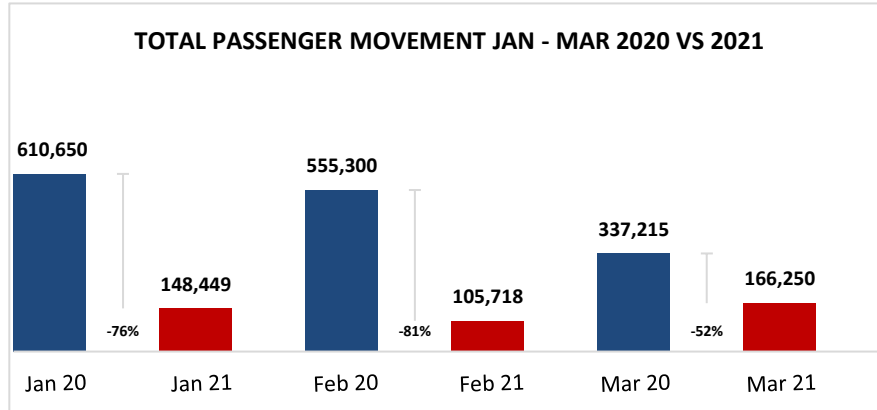
In the first quarter of 2021, January to March, Jamaica FIR recorded a total overflight aircraft movement of **20,779**, this represents a decrease of **25%** from the **27,718** overflight aircraft movements in Q1 2020. The average number of daily overflights for the period January to March 2020 and 2021 were **307** and **258** respectively.

Passenger Movements at NMIA & SIA

Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the first quarter 2021 was **420,417** a decline of **72%** from the figure reported for the same period in 2020, which was **1,503,165** departures, arrivals and transit passengers.

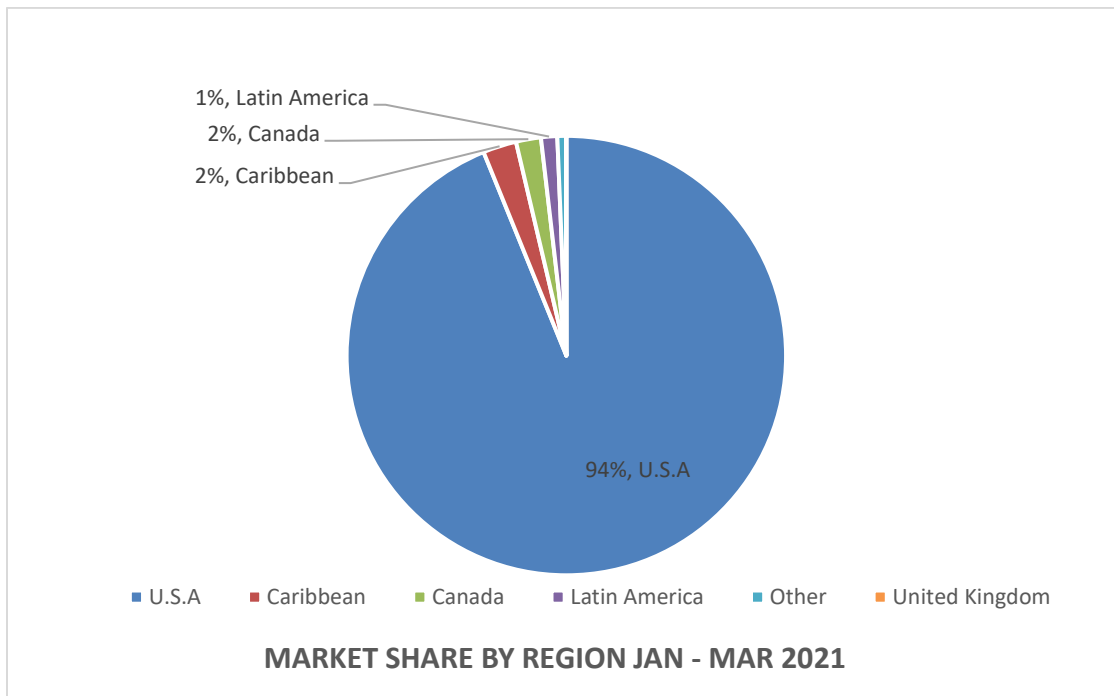

Passenger Arrival by Region

Total passenger arrivals for the reporting period were **193,455**. This is a significant decrease of **72%** from the figure of **694,729** arrivals reported for the same period in 2019.

Passenger Arrival by International Airports & Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **75%** (**144,104**) of total arrivals for the January to March 2021 reporting period. Total arrivals at NMIA for the same period was (**49,351**) or **25%**.

The load factor for total arrivals for the period January to March 2021 was **41%**. Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **39%** of all international flights were occupied whereas approximately **46%** was occupied at NMIA.
