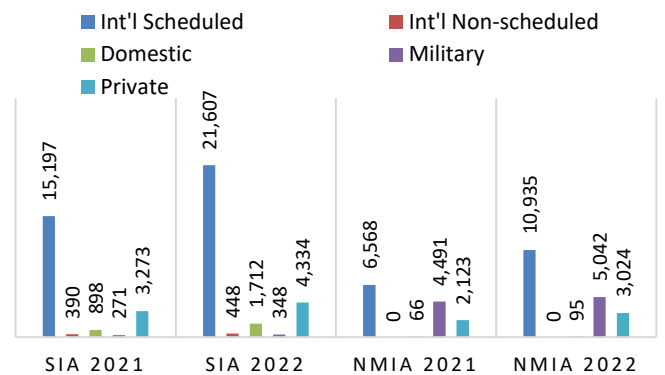


Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster’s International Airport (SIA) for the period July to September 2022 were **16,061**, an increase of **33%** when compared to the **12,033** aircraft movement recorded in the same quarter in 2021.

Year to date, January to September 2022, aircraft movements at SIA & NMIA increased by **43%**, with **47,545** aircraft movements compared to **33,277** in 2021.

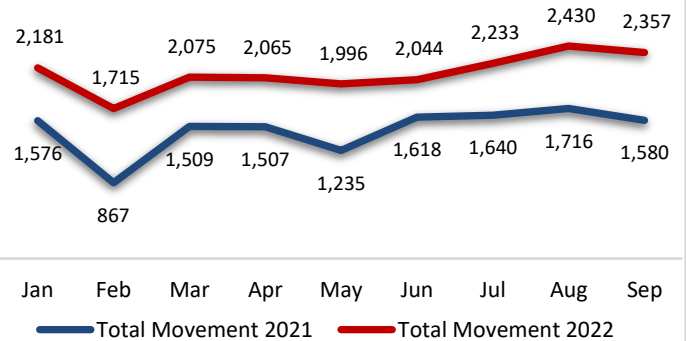
AIRCRAFT MOVEMENT SIA & NMIA JAN - SEP 2021 VS 2022



Norman Manley International Airport

Aircraft movements at NMIA for the third quarter 2022 totaled **7,020**, an increase of **42%** when compared to same period in 2021 where movements were **4,936**. Of the total aircraft for the 2022 period, **4,362** were international scheduled aircraft, **33** domestic aircraft, **1,522** military aircraft and **1,103** private aircraft. For the 2021 period of the **4,936** aircraft, **2,534** were international scheduled aircraft, **16** domestic aircraft, **1,616** military aircraft and **770** private aircraft.

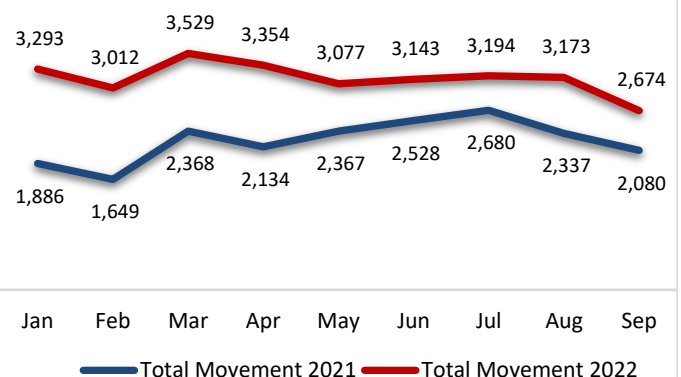
Aircraft Movement at NMIA Jan - Sep 2021 VS 2022



Sangster’s International Airport (SIA)

At the SIA, total aircraft movements in the third quarter of 2022 were **9,041** compared to **7,029** aircraft in the same period in 2021, an increase of **29%**. Of the aircraft for the 2022 reporting period **7,021** were international scheduled, **175** international non-scheduled, **534** domestic aircraft, **151** military aircraft and **1,160** were private aircraft. For the 2021 period of the aircraft **7,097** aircraft, **5,532** were international scheduled, **145** international non-scheduled, **285** domestic aircraft, **69** military aircraft and **1,066** private aircraft.

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period July to September 2022 at the domestic aerodromes and IFIA were **3,455** an increase of **77%** from the **1,947**, aircraft recorded for the same period in 2021.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **117%** to **2,027** aircraft; **1,010** arrivals and **1,017** departures, conversely for same period in 2021, **933** aircraft were recorded; **467** arrivals and **466** departures.

NEGRIL (NEG)

Negril Aerodrome also reported an increase in aircraft movement for the July to September 2022 period. Movements increased by **26%** to **1,065** aircraft from **846** aircraft reported for the 2021 period. The 2022 period recorded **532** arrivals and **533** departures whereas the 2021 period recorded equal arrivals and departure of **423**.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

Aircraft movement at IFIA increased by **63%** to **202** with **107** arrivals and **95** departures. Movements for the 2021 period were **124** aircraft with **63** landings and **61** takeoffs.

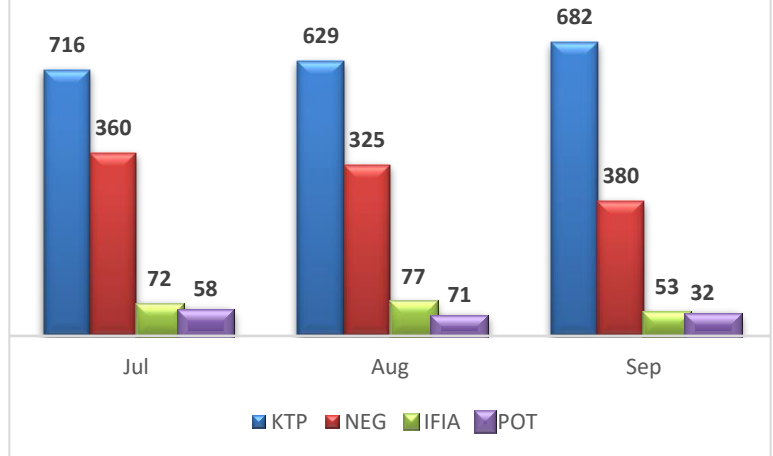
KEN JONES (POT)

Ken Jones Aerodrome noted **161** aircraft movement from July to September 2022. This was a **48%** rise from **44** aircraft arrivals and departure for the period in 2021. There were **81** arrivals and **80** departures for the 2022 and equal arrivals and departures for the 2021 reporting periods.

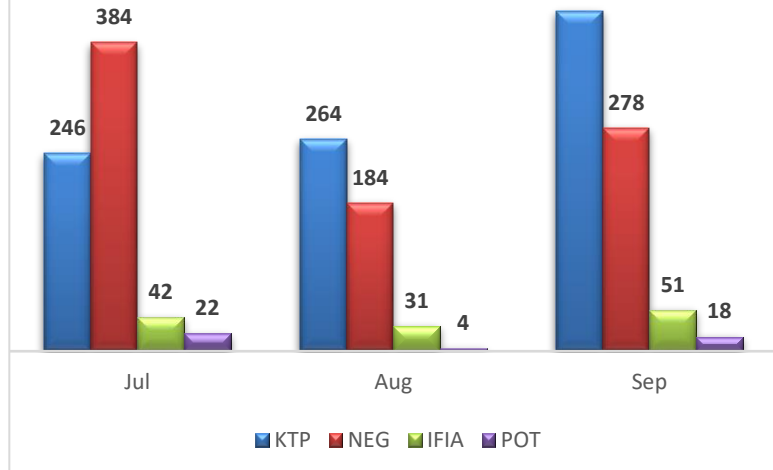

Aircraft Movements at Domestic Aerodromes Jul - Sep 2022



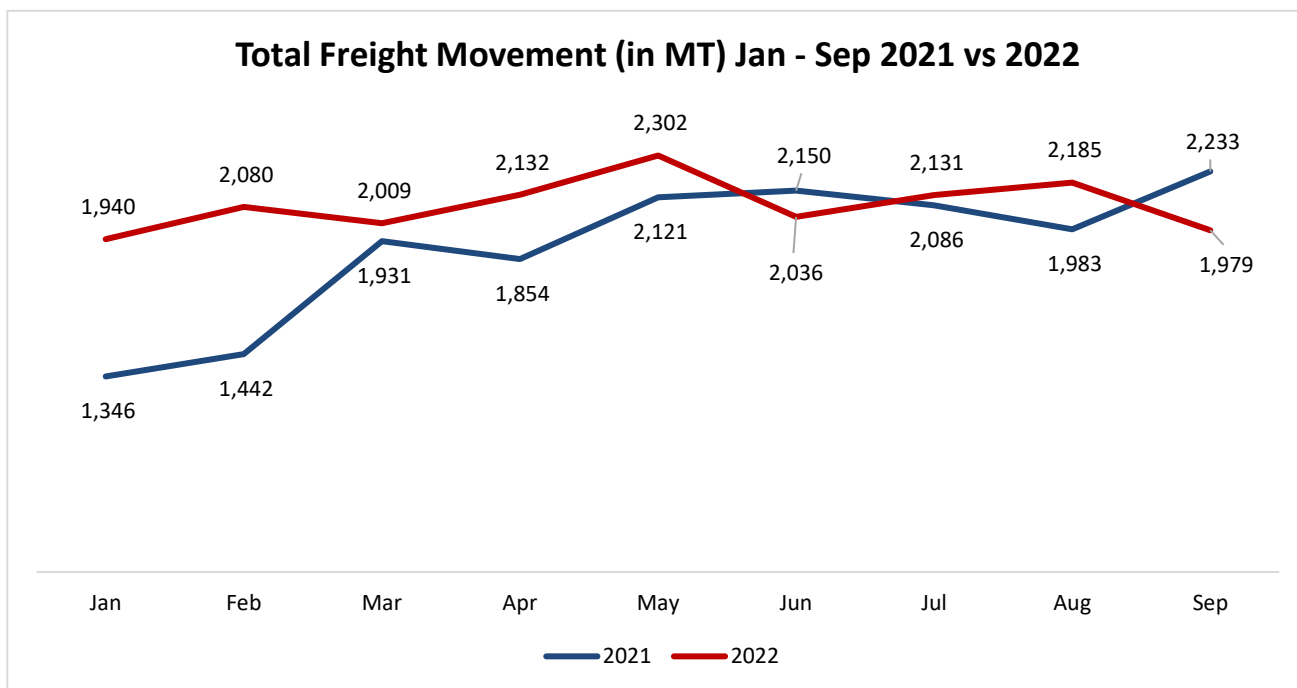
Aircraft Movements at Domestic Aerodromes Jul - Sep 2021



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the quarter July to September 2022 were **6,295 metric tonne (MT)**, which represents a slight decrease of **0.1%** in freight movement from **6,302MT** for the same period of 2021. Freight movement for the reporting period at NMIA was **5,046**; **1,481MT** loaded freight and **3,565MT** unloaded freights. On the other hand, SIA contributed **1,249MT** of freight, **1,016MT** loaded and **360MT** of unloaded freight.

Year to date 2022 freight movement increased by **10%** coming from **17,146MT** in 2021 to **18,794MT** in the year 2022.



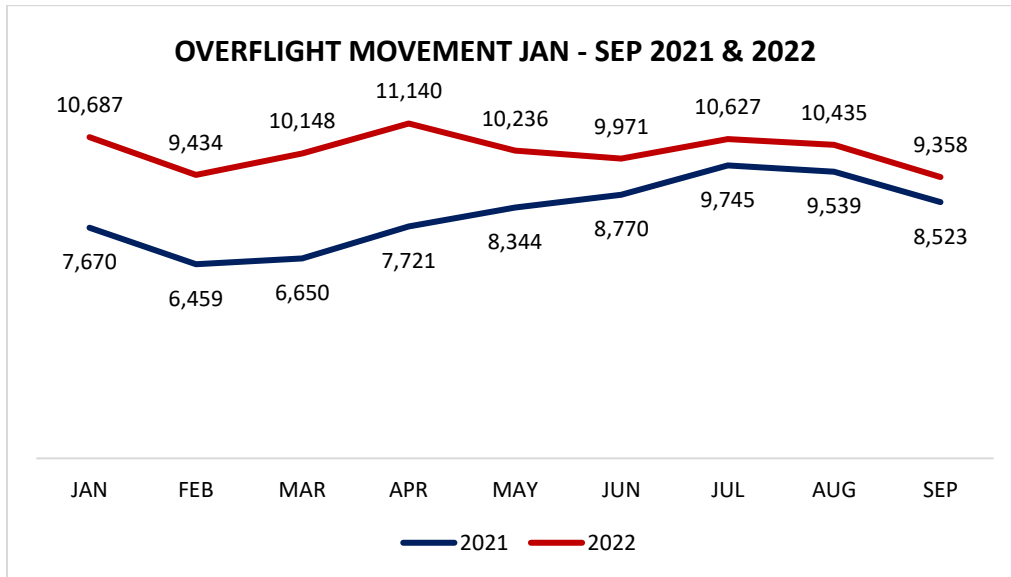

Overflight Aircraft Movements

In the third quarter of 2022, July to September, Jamaica FIR recorded a total overflight aircraft movement of **30,420**, this represents an increase of **9%** from the **27,807** overflight aircraft movements in 2021. The average number of daily overflights for the period July to September 2021 and 2022 were **302** and **330** respectively.

Year to date, January to September 2022, overflight movement increased by **25%** with **92,036** overflight movements compared to **73,421** overflights in 2021.



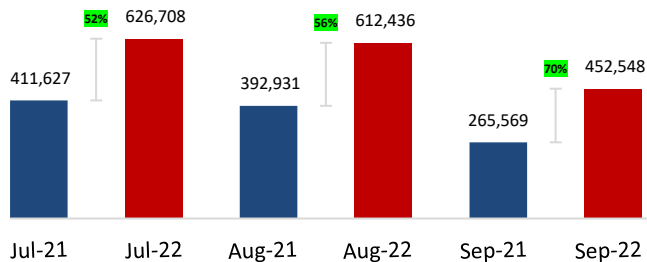

Passenger Movements at NMIA & SIA

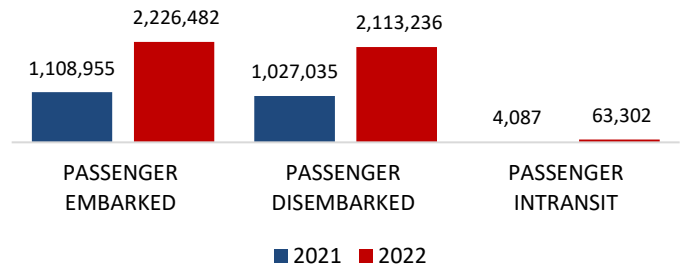
Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the third quarter 2022 was **1,691,692** an increase of **58%** from the figure reported for the same period in 2021, which was **1,070,127** departures, arrivals and transit passengers.

Year to date, January to September 2022, passenger movements increased by **89%**, with **4,403,020** passenger movements compared to **2,332,403** in 2021.

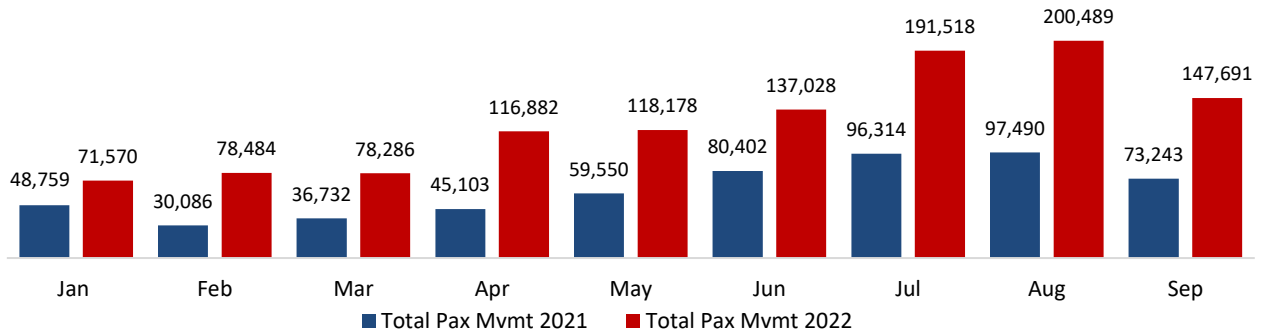
Total Passenger Movement Jul-Sep 2021 vs 2022



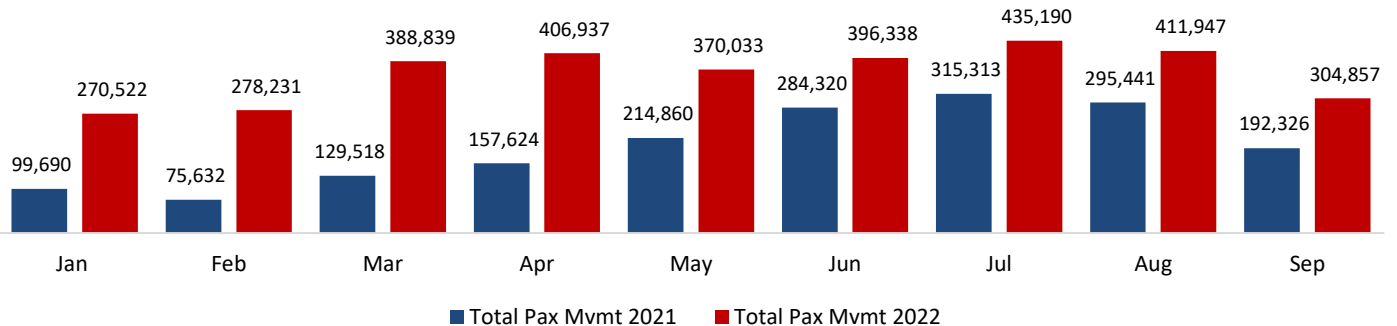
Total Passenger Movement January - September 2021 vs 2022

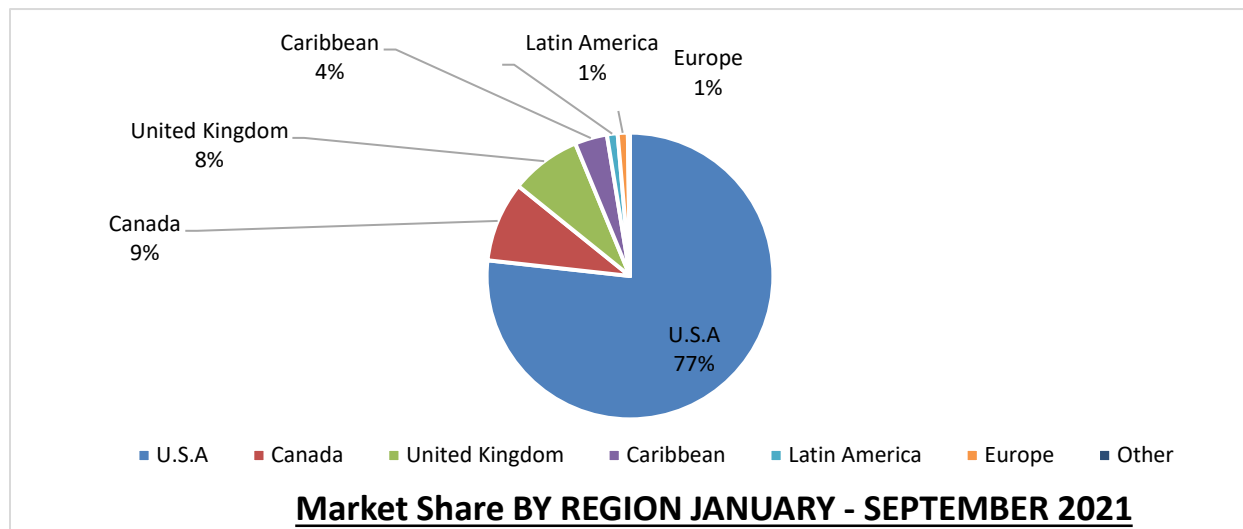

Passenger Arrival by Region

Total passenger arrivals for the reporting period were **802,506**. This represented an increase of **55%** from **517,318** arrivals reported for the same period in 2021. Year to date, passenger arrivals are up **88%**, that is **2,113,236** arrivals from January to September 2022 versus **1,121,451** arrivals for same period in 2021.

Passenger Arrival by International Airports and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **75% (1,583,766)** of total arrivals for the January to September 2021 reporting period. Total arrivals at NMIA for the same period was **529,470** or **25%**.

The load factor for total arrivals for the period January to September 2022 was **78%**. Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **79%** of all international flights were occupied whereas approximately **76%** were occupied at NMIA.

Permits, Flight Authorization and Licenses Issued
