Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period July to September 2023 were **15,716**, a decrease of **2%** when compared to the **16,061** aircraft movement recorded in the same quarter in 2022.

Year to date, January to September 2023, aircraft movements at SIA and NMIA increased by **5%**, with **50,074** aircraft movements compared to **47,545** in 2022.


Norman Manley International Airport (NMIA)


Aircraft movements at NMIA for the third quarter 2023 totaled **5,210**, a decrease of **26%** when compared to same period in 2022 where movements were **7,020**. Of the **5,210** aircraft for the 2023 period, **4,084** were international scheduled aircraft, **282** military aircraft and **844** private aircraft. Of the **7,020** aircraft for the 2022 period **4,362** were international scheduled aircraft, **33** domestic aircraft, **1,522** military aircraft and **1,103** private aircraft.

Sangster's International Airport (SIA)

At the SIA, total aircraft movements in the third quarter of 2023 were **10,506** compared to **9,041** aircraft in the same period in 2022, an increase of **16%**. Of the **10,506** aircraft for the 2023 reporting period **8,156** were international scheduled, **116** international non-scheduled, **822** domestic aircraft, **36** military aircraft and **1,376** were private aircraft. Of the **9,041** aircraft for the 2022 period **7,021** were international scheduled, **175** international non-scheduled, **534** domestic aircraft, **151** military aircraft and **1,160** were private aircraft.

AIRCRAFT MOVEMENT – KTP, NEG, IFIA, POT

Overall aircraft movements for the period July to September 2023 at the domestic aerodromes and IFIA were **3,463** an increase slightly by **0.23%** from the **3,455** aircraft recorded for the same period in 2022.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period decreased by **4%** to **1,948** aircraft; **960** arrivals and **988** departures, conversely for same period in 2022, **2,027** aircraft were recorded; **1,017** arrivals and **1,010** departures.

NEGRIL (NEG)

Negril Aerodrome reported an increase in aircraft movement for the July to September 2023 period. Movements increased by **16%** to **1,236** aircraft from **1,065** aircraft reported for the 2022 period. The 2023 period recorded equal arrivals and departures whereas the 2022 period recorded **532** arrivals and **533** departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)


Aircraft movement at IFIA for the reporting period decreased by **28%** to **145** with **73** arrivals and **72** departures. Movements for the 2022 period were **202** aircraft with **107** landings and **95** takeoffs.


KEN JONES (POT)

Ken Jones Aerodrome noted **134** aircraft movement from July to September 2023. This was a **17%** decrease from **161** aircraft arrivals and departure for the period in 2022. There were **equal** aircraft arrivals and departures for the 2023 reporting period, whereas the 2022 reporting period had **81** aircraft arrivals and **80** departures.



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period July to September 2023 were **5,698 metric tonne (MT)**, which represents a **9%** decrease in freight movement from **6,295 MT** for the same period of 2022. Freight movement for the reporting period at NMIA was **4,460**; **1,279MT** loaded freight and **3,181MT** unloaded freights. On the other hand, SIA contributed **1,238MT** of freight, **1,031MT** loaded and **207MT** of unloaded freight.

Year to date 2023 freight movement decreased by **9%** coming from **18,794MT** in 2022 to **17,090MT** in the year 2023.





Overflight Aircraft Movements

In the third quarter of 2023, July to September, Jamaica's flight information region recorded total overflight aircraft movements of, **34,570** this represents an increase of **14%** from the **30,385** overflight aircraft movements in 2022. The average number of daily overflights for the period July to September 2022 and 2023 were **330** and **375** respectively.

Year to date, January to September 2023, overflight movement increased by **9%** with **99,749** overflight movements compared to **92,001** overflights in 2022.




Passenger Movements at NMIA & SIA


Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the third quarter 2023 was **1,828,279** an increase of **8%** from the figure reported for the same period in 2022, which was **1,691,692** departures, arrivals and transit passengers.

Year to date, January to September 2023, passenger movements increased by **21%**, with **5,342,683** passenger movements compared to **4,403,020** in 2022.



Passenger Arrival by Region

The reporting period recorded over **890,000** passenger arrivals. This represents an increase of **11%** from the figure of **802,000** arrivals reported for the same period in 2022. Year to date, passenger arrivals are up **24%**, that is **2,618,721** arrivals from January to September 2023 versus **2,113,236** arrivals for same period in 2022.



Passenger Arrival by International Airports and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **74% (1,940,245)** of total arrivals for the January to September 2023 reporting period. Total arrivals at NMIA for the same period was **26% or 678,476** passengers.

The load factor for total arrivals for the period January to September was **82%.** Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **84%** of all international flights were occupied whereas approximately **78%** were occupied at NMIA.
