Aircraft Movement - NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period October to December 2021 were **12,182**, an increase of **32%** when compared to the **9,251** aircraft movement recorded in the same guarter in 2020.



Year to date, January to December 2021, aircraft movements at SIA & NMIA grew by **25%**, from **38,229** aircraft movements in 2020 to **47,785** in 2021.


Norman Manley International Airport (NMIA)


Aircraft movements at NMIA for the fourth quarter 2021 totaled 5,728, an increase of 23% when compared to same period in 2020 where movements were 4,643. Of the total aircraft for the 2021 period, 2,994 were international scheduled aircraft, 2 domestic aircraft, 1,943 military aircraft and 789 private aircraft. For the 2020 period of the 4,643 aircraft, 2,145 were international scheduled aircraft, 92 domestic aircraft, 1,668 military aircraft and 738 private aircraft.


Sangster's International Airport (SIA)

At the SIA, total aircraft movements in the fourth quarter of 2021 were **8,780** compared to **5,583** aircraft in the same period in 2020, an increase of **57%**. Of the aircraft for the 2021 reporting period **6,640** were international scheduled, **146** international nonscheduled, **443** domestic aircraft, **145** military aircraft and **1,406** private aircraft. For the 2020 period of the aircraft **3,092** were international scheduled aircraft, **343** international non-scheduled, **319** domestic aircraft, **67** military aircraft and **787** private aircraft.

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period October to December 2021 at the domestic aerodromes and IFIA were **2,906** an increase of **70%** from the **1,709** aircraft recorded for the same period in 2020.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **56%** to **1,305** aircraft; **656** arrivals and **649** departures, conversely for same period in 2020, **836** aircraft were recorded; **418** arrivals and **418** departures.

NEGRIL (NEG)

Negril Aerodrome also reported an increase in aircraft movement for the October to December 2021 period. Movements increased by **56%** to **1,120** aircraft from **720** aircraft reported for the 2020 period. Arrivals and departure for the 2020 period were **362** and **358** respectively, whereas the 2021 period recorded equal arrivals and departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)


Aircraft movement at IFIA increased by **301%** to **385** with **193** landings and **192** takeoffs. Movements for the 2020 period were **96 aircraft** with **equal** landings and takeoffs.


KEN JONES (POT)

Ken Jones Aerodrome noted **96** aircraft movement from October to December 2021. This was a **104%** increase from **47** aircraft arrivals and departure for the period in 2020. There were equal arrivals and departure in 2021 and **23** arrivals and **24** departures in 2020.






CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period October to December 2021 were **5,656 metric tonne (MT)**, which represents a **22%** increase in freight movement from **5,652 MT** in the same period of 2020. Freight movement for the reporting period at NMIA was **4,294MT**; **1,615MT** loaded freight and **2,679MT** unloaded freights. On the other hand, SIA contributed **1,362MT** of freight, **1,074MT** loaded and **288MT** of unloaded freight.

For the reporting year 2021 freight movement increased by **11**% coming from **20,592MT** in 2020 to **22,802MT** in the year 2021.





Overflight Aircraft Movements

In the fourth quarter of 2021, October to December, Jamaica FIR recorded a total overflight aircraft movement of **29,060**, this represents an increase of **69%** from the **17,171** overflight aircraft movements in 2020. The average number of daily overflights for the period October to December 2020 and 2021 were **186** and **315** respectively.

Year to date, January to December 2021, overflight movement increased by **65%** with **102,481** overflight movements compared to **62,151** overflights in 2020.




Passenger Movements at NMIA & SIA


Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the fourth quarter 2021 was **1,087,871** an increase of **160%** from the figure reported for the same period in 2020, which was **418,335** departures, arrivals and transit passengers.

Year to date, January to December, passenger movements increased by **52%**, with **3,420,274** passenger arrivals and departures compared to **2,254,478** in 2020.



Passenger Arrival by Region

Total passenger arrivals for the reporting period were **578,885.** This is an increase of **149%** from the passenger movement of **232,933** arrivals reported for the same period in 2020. Year to date, passenger arrivals are up **56%**, that is **1,700,336** arrivals from January to December 2021 versus **1,088,045** arrivals for same period in 2020.

Passenger Arrival by International Airports and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **76% (1,296,139)** of total arrivals for the January to December 2021 reporting period. Total arrivals at NMIA for the same period was **404,197** or **24%**.

The load factor for total arrivals for the period January to December 2021 was **69%.** Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **69%** of all international flights were occupied whereas approximately **67%** were occupied at NMIA.
